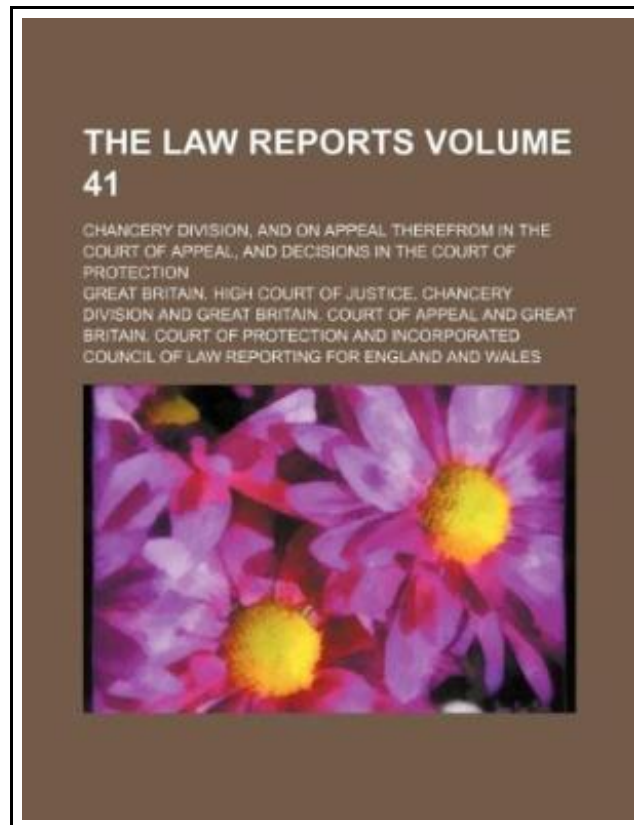

Defendant to shew why he did not offer a larger rent, and does not prevent his offer from being a simple unqualified one. Then it was said that other terms were introduced by subsequent letters, and the case of Hussey v. Home-Payne (1) was relied on as shewing that in such circumstances there was no concluded contract. But the judgment of Lord Cairns in that case shews that it was not because the subsequent letters raised a doubt, that it was held that the two original letters did not form a completed agreement, but because the two original letters of themselves contained terms which raised the doubt. That case therefore is not applicable, and in my opinion there was a binding contract constituted by these two letters alone. But then it is said that on the 13th of January, 1887, the Defendant entirely withdrew the offer he had made. Of course the withdrawal could not be effective, if it were made after the contract had become complete. As soon as an offer has been accepted the contract is complete. But it is said that there could be a withdrawal by the Defendant on the 13th of January on this ground, that the offer of the Defendant had been accepted by Seratchley, a director of the Plaintiff company, who was...
